In 1962, at the IGAS (International Grapho Analysis Society) Conference in Chicago, members sought for a greater latitude in the use and instructions evolving in the techniques of Handwriting Analysis, they wanted broader exposure to research literature that was becoming available in the field. They wanted to discuss gestalt, or holistic, graphology with others without fear of being excommunicated from the IGAS "Society." Rebels were dismissed and stripped of their certification.



Callirobics vs Graphotherapy

Callirobics (a mash up of Calligraphy and Aerobics) means the same as Graphotherapy.


No matter how you say it, is all about repetitive writing patterns (using straight and curved lines) set to music. The Rhythm of the Music helps the user to relax and develop an internal writing rhythm. The exercises make learning to write more interesting and fun than tedious penmanship classes.

The differences the craft and the science are minor. It amounts to *who* is using this field of handwriting.


The term Graphotherapy is most commonly used by Graphologists and people with handwriting analysis backgrounds. This science began with psychiatrists, psychologists and physicians in Europe.

In the early 1960's graphologist Paul de Sainte Colombe introduced this into the United States. His book, *"Grapho-Therapeutics"* explained how the visual, spatial exercises and subconscious patterns worked together to help many people achieve healing and overcome many physical and stimulate psychological changes for desired results.

The term Callirobics is most often used by Occupational Therapists that work with children to learn how to write; with children that may have learning disabilities including ADHA and ADD; and with older adults who may have













suffered from brain injury or surgery.

Graphologist Jeannette Farmer pioneered a career of working with children with attention deficient disorders, and perfected a system using music and rhythmic strokes and drawn forms to improve attention without medications. Although Jeannette passed several years ago, her family updated and maintains her business at <u>https://</u> retrainthebrain.com/

Graphologist Liora Laufer, wrote the book "*Callirobics with Liora Lauffer: Handwriting Exercises*" in the early 1990's that sparked the Occupational Therapy Researchers to learn more about how this really works. Her website is https:// www.callirobics.com/

Callirobics has uniquely surpassed Graphotherapy in the area of scientific research. The Journal of Occupational Therapy has used Callirobics in many studies of the effects of this method on persons that have struggled to regain fine motor control in their arms and hands following head trauma (such as concussions, stroke, surgery, diseases like Parkinsons others.)

Erica Karohs and Sheila Lowe also have excellent books on the subject.

Regardless of the name you apply to this, Graphotherapy really works!

Introducing Script-Tips

"Script-Tips" is a little booklet of what the author calls "Grapho LOGIC Cartoons" about handwriting analysis by Leo Martello. The book, published in NY in 1968, didn't make much of a stir at the time. Graphology was prominent then, but the book on cartoons were distributed locally.

Leo Martello started reading about graphology when he was 12. His first book on graphology was the Louise Rice book, "Character Reading From Handwriting." Martello claims that years later "I got to know this fascinating and dynamic woman just before her demise."

Armed with a mail order course in Handwriting Analysis, and plenty of books, he worked to be a "Professional" at age 15. He practiced and read more about this fascinating subject, and increased his



knowledge through independent reading. By the time he was 16, Leo was making radio appearances as a graphologist, talking about handwriting samples of the day. Before he graduated high school, Leo was already writing magazine articles about graphology.

Upon graduation, he moved to NYC were he knew other family members. He attended Hunter University and The Institute for Psychotherapy there.

He served as treasurer for the American Graphological Society from 1955-1957, which was a New York City based organization. Around this time, he had been writing a newspaper column called "Your Handwriting Tells." This column continued for eight years in the Chelsea News.

During this time, he's main source of income was from his newspaper, magazine articles, and working as a freelance graphologist and with some corporate clients doing mainly HR work.

Over the next twenty years, Martello had written what he claimed to be "hundreds" of articles and columns in the likes of magazines of Family Circle, Hobby Digest, Canadian Analyst, and more. And, he appeared on numerous radio and TV shows such as David Susskind, Alan Burke, Mike Douglass, and Barry Farber.

In addition to "Script-Tips" his other published books regarding graphology include "Your Pen Personality", "Handwriting Analyst's How-To."

During the 1960-70's, Martello was active in many social and political movements including the Vietnam anti-draft, Hypno-graphology, Parapsychology, Gay Activist Alliance, and one of the founding members of WICA (Witches International Craft Associates.)

Martello passed in 2000 at the age of 70 after a lengthy battle with cancer.

We will be sharing his clever and relevant legacy of "Script-Tips" in future Dialogue issues.

Eileen Page, our Membership Chair, estimates she should be able have an updated Membership Directory prepared to email to everyone by the first of the new year.


This has been a very encouraging year for AAHA. In addition to our monthly study group meetings, we had a two-day online conference in July which was very well attended, proved to be fun and informative.

Our by-law articles call for a nine-member board. During my terms as BOT Chair, we have lost Ed Jackson, Liz Mills, Karen Whittemore, and Dave Grayson. Despite these very sad losses, we have brought our BOT to seven with Kathleen and Barbara. Life members are eligible to serve and constitute one-third of AAHA membership. There was only one individual who took part one of the Associative Exam. This person was unable to pass and was encouraged to continue with studies. It takes courage to see what the exam is all about, but also promotes a sense of the greater part of this profession we value as a science with integrity.

There was one other person who signed up to take the Test but needed more time to do it properly. An additional person requested information for the Test, but also had other commitments and will pursue taking the Test when more time permits.

Bylaws & Rules Committee - Annual Report, 2022 / Kitty Holm

I, as the AAHA Bylaws, Rules, and Procedures (BR&P) Chair and a member of the AAHA Executive committee, attended all the monthly Executive meetings as parliamentary proceedings advisor to the AAHA President (Article IX, section 4, item e).

Amendments to the AAHA Bylaws, Rules, and Procedures can only take place at the even year convention. Eleven amendments were submitted to the AAHA BR&P Chair which were assembled and made ready for voting. Voting took place by mail and through the AAHA website. Votes were sent to the AAHA Secretary who in conjunction with the AAHA BR&P Chair presented the voting outcome at the 2022 AAHA/AHAF online convention general meeting. All amendments to the AAHA BR&P can only take place in the General meeting at the convention (Article XII).
